Application

Stellisept® med gloves are gentle, easy-to-use soft PET cleaning gloves with mild caring properties, coming with antimicrobial effect. Due to the mild, skin-compatible formulation of Stellisept® med gloves soaking solution, rinsing with water after use is not necessary. Stellisept med gloves are a convenient solution for an uncomplicated and at the same time pleasantly hygienic, antiseptic body wash of immobile, bedridden patients. To make a full-body wash as comfortable as possible for an immobile person who depends on care, Stellisept® med gloves can be heated in the microwave or refrigerated beforehand to make the experience more refreshing.

Areas of application

Stellisept® med gloves wash gloves are suitable for hygienic body washing with a wide range of antibacterial efficacy spectrum and helps to care for the skin and increases the skin moisture, with a 3-fold care complex. Selected ingredients with gentle skin properties also ensure very good skin compatibility. Rinsing after use is not necessary.

Stellisept® med gloves have been particularly developed for the following areas of application:

- Nursing, antiseptic body wash for immobile patients, to strengthen the skin's protective barrier with moisturizing care complex
- Nourishing antimicrobial body wash of immobile patients with MRSA and VRE
- Contributes to maintain the protective function of the skin and reduce the body's own microbial flora/germ load
- Suitable for hygienic body cleansing of bedridden patients before surgical procedures
- Care and protection of irritated skin of patients in home care who suffer from incontinence

Directions for use

Gentle antibacterial full-body washing with a 3-fold care complex for immobile patients, including those with MRSA or VRE.

Stellisept® med gloves are ready-to-use wash-gloves. If preferred, Stellisept med gloves can be warmed in the microwave for a more pleasant application, please insert the closed Stellisept® med gloves flow-pack into the microwave up to two times for 30 seconds at 750 watt each time. Alternatively the gloves can be cooled for a refreshing application in summer time.

Each Stellisept® med gloves flow-pack contains 10 gloves.

To prevent spreading dirt or microorganisms on the body it is recommended to use a fresh glove for each body region.

Remove residues of other soaps or wash lotions with water prior to the use of Stellisept® med gloves.

The high-quality cloth material ensures an effectively substance release at each application and the selected ingredients make the gloves well compatible and a rinse is not necessary after application.

As a result, the effort for the patient cleaning is being reduced and the cleaning is more comfortable for the bed-ridden patient.



Skin-compatible MRSA decolonisation



Body cleansing preparations with proven MRSA efficacy are a component of decolonisation in case of MRSA colonization [1]. In addition to the proof of bactericidal activity [2], skin compatibility also plays an important role in the selection of products.

Appropriate evidence is provided by application tests carried out under specialist dermatological control of skin compatibility on mucous membranes [3, 4]. Cleansing preparations that remain on the skin - so-called leave-on products - must prove their skin compatibility according to the EU Cosmetics Directive [5, 6]. The selection of appropriate ingredients ensures that the skin is not irritated despite the antimicrobial effect of the cleansing products.

Dosage

	Contact time

For the body washing or MRSA eradication using Stellisept® med gloves 10 disposable wash gloves are needed.

1. face and hair

Clean the entire face with a Stellisept® med glove. It must be ensured that the eyes of the patient are closed during the procedure. Treat the areas around the eyes with care, as the solution must not get into the eyes. When cleaning the ears, make sure the solution does not run into the ear. Short hair can be washed with the Stellisept® med gloves. Massage the hair with the glove, no rinse necessary. For longer hair and a sufficient wetting the use of Stellisept® med foam is recommended.

2. breast and stomach

Apply a Stellisept® med glove and clean from the neck downwards.

3.-4. arms

The arms have to be cleaned with a fresh wash glove each. Wash arms from the fingertips to the shoulders. Make sure the gaps between fingers and the armpit are sufficiently moistened with the solution.

5. genital area

Use a fresh wash glove to clean the genital area.

6.- 7. legs

Wash each leg with a fresh wash glove from the hips downwards. Make sure the gaps between toes are sufficiently moistened with the solution.

8. body side and back

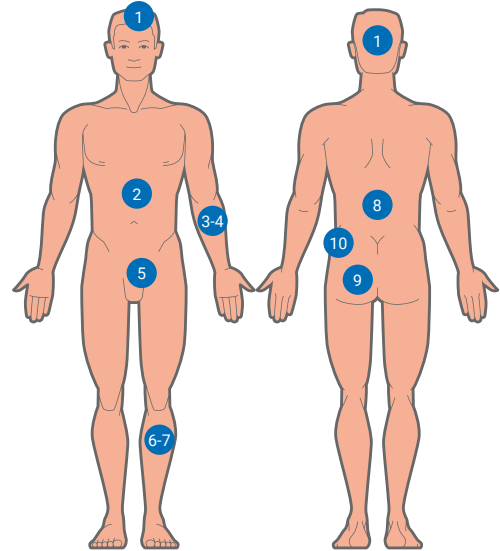
After turning the patient, clean one body side and the back from the neck downwards with a fresh glove.

9. buttocks

Clean buttocks with a fresh wash glove.

10. other body side

Change the bed linen then turn the patient around again and clean the other patient's body side with a fresh glove.
