# Stellisept® med

is a hygienic, antibacterial wash lotion. Exceedingly gentle on skin with fast-acting antibacterial effectiveness, it is quick to apply even as part of a hygienic, antibacterial full-body wash.

## Characteristics

- Mild nourishing, antibacterial hygienic hand and body rinse-off wash lotion to strengthen the skin's protective barrier through moisturizing care complex
- Suitable for hygienic body washing/cleaning of patients before clinical stay (Rinse-Off wash-lotion)
- Contributes to the reduction of bacteria, including MRSA and VRE, within 30 seconds
- Pleasant scent
- Without alcohol and colorants

## Application

Stellisept® med is suitable both for hygienic hand washing and serves as a caring and skin-friendly alternative to conventional decontamination preparations for the hygienic, antibacterial body washing and for sanitation in cases of MRSA colonisation.

Its mild tensides are gentle on the mucous membrane, making Stellisept® med significantly gentler than conventional full-body cleaning products. The ingredient panthenol stimulates skin regeneration and supports its natural protective barrier. Many users say that Stellisept® med is kind to the skin.

Stellisept® med is effective against national epidemic strains of MRSA and clinical MRSA-isolates within 30 seconds. The wash lotion is also ideal for hygienic hand washing as it is extremely gentle on the skin and mucous membrane. Its effectiveness has been tested under European standards. Stellisept® med is tested according to EN 13727 and EN 1499.

## Areas of application

Stellisept® med has been particularly developed for the following areas of application:

- Nourishing antibacterial whole-body washing (incl. hair) of mobile and bed-ridden patients with MRSA, VRE
- Suitable for hygienic body washing/cleaning of patients before clinical stay
- Care and protection of irritated skin of patients in home care who suffer from incontinence
- Hygienic hand and body wash to strengthen the skin's protective barrier through moisturizing care complex
- Contributes to maintain the protective function of the skin and reduce the body's own microbial flora/germ load

## Directions for use

Stellisept® med is used in combination with water. Remove residues of other soaps or wash lotions with water prior to the use of Stellisept® med. Apply the product to moistened skin for intensive cleansing. After at least 30s (according to EN 1499), rinse thoroughly with clear water.

Information for MRSA eradication: Depending on the size and hair length of the patient, 200 ml Stellisept® med is needed for a 5 day MRSA eradication cycle.

## Hygienic, antibacterial full-body washing, effective against MRSA and VRE, for mobile patients:

In addition to its 3-fold care complex, Stellisept® med is proven to be effective against MRSA and VRE while also being exceptionally gentle on skin. Stellisept® med has been proven effective under the European testing standard EN 13727 against six national epidemic strains of MRSA and a large number of clinically isolated strains from various regions of Germany. A sufficient number of reduction factors against all tested strains were evident after 30 seconds with Stellisept® med.

Moisten body and hair under the shower, then turn off the water. Apply Stellisept med directly on to wet skin and wet hair ensuring a complete wetting of the product. Keep eyes closed during the washing procedure. The solution should be used with caution when applied near the eyes and shall not get into the eyes. Stellisept® med should be applied for at least 30 seconds and rinsed off with clear water afterwards. Dry skin with a fresh and clean towel.

## Hygienic hand washing

Stellisept® med is a gentle, highly effective alternative to conventional wash lotions for kitchens, food processing areas, healthcare and sanitary facilities. The product meets the requirements of EN 13727 and EN 1499 in just 30 seconds.

Wet hands with water. Apply a sufficient amount of Stellisept med on to wet hands and distribute, massage product into the hands for at least 30 seconds (according to EN 1499). Afterwards, thoroughly rinse hands under running water and dry them with a disposable towel.

## Skin-compatible MRSA decolonisation



Body cleansing preparations with proven MRSA efficacy are a component of decolonisation in case of MRSA colonization [1]. In addition to the proof of bactericidal activity [2], skin compatibility also plays an important role in the selection of products.

Appropriate evidence is provided by application tests carried out under specialist dermatological control of skin compatibility on mucous membranes [3, 4]. Cleansing preparations that remain on the skin - so-called leave-on products - must prove their skin compatibility according to the EU Cosmetics Directive [5, 6]. The selection of appropriate ingredients ensures that the skin is not irritated despite the antimicrobial effect of the cleansing products.

For the body washing or MRSA eradication using Stellisept® med fresh water and approximately 10 disposable washcloths as well as fresh towels are needed.

**1. face and hair**

Apply Stellisept med on a washcloth and clean the entire face. It must be ensured that the eyes of the patient are closed during the procedure. Treat the areas around the eyes with care, as the solution must not get into the eyes. To apply Stellisept® med to the outer ear a damped cotton stick may be used. When cleaning the ears, make sure the solution does not run into the ear.

Stellisept® med can also be used as a shampoo for the hair. Apply directly to the hair and rinse off after the exposure time.

**2. breast and stomach**

Apply Stellisept med with a fresh washcloth to the torso and clean from the neck downwards.

**3.-4. arms**

The arms are to be cleaned with a fresh washcloth each. Wash arms from the fingertips to the shoulders. Make sure the gaps between fingers

and the armpit are sufficiently moistened with the preparation.

**5. genital area**

Use a fresh washcloth to clean the genital area.

**6.- 7. legs**

Wash each leg with a fresh washcloth from the hips downwards. Make sure the gaps between toes are sufficiently moistened with the preparation.

**8. body side and back**

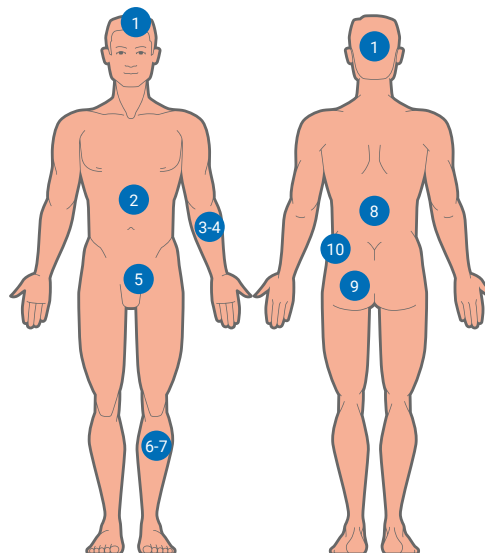
After turning the patient clean one body side and the back from the neck downwards with a fresh washcloth.

**9. buttocks**

Clean buttocks with a fresh washcloth.

**10. other body side**

Change the bed linen then turn the patient around again and clean the other patient's body side with a fresh washcloth.
